David S. "Scott" Sherman grew up in the northern part of rural Hardy County, WV, the youngest of three children. His mom and dad not only raised him in the family home, but aside from school, most of his childhood was spent alongside his mom and dad operating the family's country store. It was a country store that wasn't a lot different from the perceptions and memories of small rural country stores that we all share, and while he didn't realize it at the time, he was learning a lot of valuable lessons and skills that have helped him throughout his life. After graduating from high school, he completed a degree in Industrial Engineering at WVU.

From there, he set off to join the corporate world and lived in different places throughout the east coast for a few years. However, due to his father's untimely terminal illness, he returned back home to Hardy County, WV to help out and takeover land that was once the family's small farm. Scott currently serves as the Chairman of the Board for CSSA and at the end of 2019, will conclude a 10 year stint with NTCA-SMC's Board of Directors; having served the last 4 years as its chairman.

In his "spare time", he enjoys raising his son, Adam, and farming with lots of help from family and friends. Some time ago, he completed an 8 year stint on the Board of Governors for Eastern West Virginia Technical and Community College, and decided to shift his focus back to another passion, Boy Scouts. As an Eagle Scout, the satisfaction of seeing one's son aspire to achieve that same scouting goal encouraged him to be a Cub Scout Den Leader for 5 years and is currently an Assistant Scout Master for Moorefield Boy Scout Troop 60. 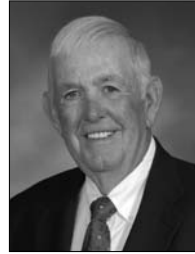

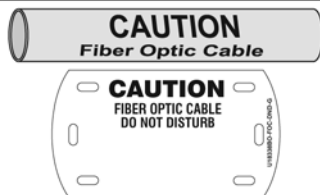

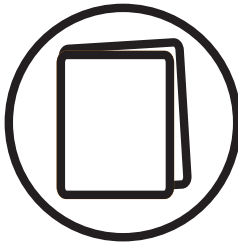
