Telco and ISP Privacy: Yesterday, Today, and Tomorrow

In this session, we will discuss the history of privacy law and regulation of telcos and ISPs past, present, and future. We will begin with the FCC's attempt to regulate privacy in 2016, and then discuss the various attempts by some states to enact privacy laws of their own when the FCC's regulations failed. We will next discuss the privacy landscape as it applies to telcos and ISPs today. Finally, we will discuss the future of privacy law for telcos and ISPs, including the recently proposed American Data and Privacy Protection Act.

Budgeting & Forecasting for Broadband Projects and Operations *Todd Thorson, CPA, FORVIS*
